# OFFICIAL RULES

## East Los Angeles Mexican Independence Day Parade



1. All entries must be approved by the Parade Committee. Any deviation from these rules must be approved during the time of application.
2. The Parade Committee will not be responsible for false statements made by applicants.
3. All participants must be uniformed in Mexican-themed costumes and appropriately attired.
4. Political, or social advertising is prohibited. Anyone who violates this policy will be disqualified immediately.
5. **Check-in closes promptly at 10:15am.** All participants will be in their parade line-up position by 10:30am. (Otherwise CMCP is not responsible for your position in the parade line up).
6. Line up formation will be on a first come first serve basis with the application and payment.
7. Marching bands are allowed up to 20 persons. (Exception: School Marching Bands, Charros, or folklore groups).
8. Due to the extreme heat, children under 8 years of age are not permitted to march.
9. The distribution of handouts, literature, etc. of any sort is strictly prohibited.
10. Parade participants may not approach or have any direct contact with the crowd at any time.
11. Participants must remain inside their respective vehicles for the duration of the parade route.
12. Enclosed vehicles are prohibited. (Violations subject to disqualification).
13. NO fireworks, sirens, or loud noises that interfere with other entries.
14. Consumption of alcohol before or during the parade is strictly **PROHIBITED**. Anyone who violates this policy will be removed from the parade immediately.
15. Equestrian and motorized entries must have proof of insurance submitted with application. Furthermore, a **clean-up team must accompany** each equestrian group at all times on the day of the event.
16. FORWARD motion must be maintained when passing in front of the TV cameras and throughout the parade route. (Violations subject to disqualification).
17. CMCP is not responsible or subject to any liability for any entries that are not apart of the local TV broadcast for the parade.
18. **Payment must be received by Thursday, August 8<sup>th</sup> 2013.** Failure to pay in a timely manner will result in non-participation. (No exceptions)
